1. The Client signing the Booking Application form does so on behalf of all persons in the group. The signing of the Booking Application Form shall constitute acceptance by the Client of the Booking Conditions as set out herein. If for any reason the booking cannot be accepted, the deposit will be promptly refunded in full, but Boulder Adventures Ltd cannot accept any liability for any delay or additional expense incurred on that account.
2. Boulder Adventures require a deposit of 20% per person with the Booking Form. No booking is considered confirmed until the deposit has been received.
3. Boulder Adventures reserves the right to cancel any booking provided that in such event an attempt will be made to offer the Client an alternative accommodation or time, but if no such alternative is available (such availability to be decided at the absolute discretion of Boulder Adventures Ltd) the Client shall be entitled to a full refund of all monies paid, all liability of Boulder Adventures Ltd shall cease.
4. Boulder Adventures Ltd reserve the right to make reasonable variation or modification to any accommodation, which may be necessary from time to time. Accommodation arrangements are at the sole discretion of Boulder Adventures Ltd but wherever possible we will try to ensure that your party is accommodated in its own room.
