SELF CATERING ACCOMMODATION BOOKING TERMS & CONDITIONS

In all that follows the terms we/us/our means Boulder Adventures Ltd. and the terms you/your means the person making the booking on behalf of the group.

1. The person making the booking does so on behalf of all persons in the group. This person, by making the booking, accepts all of the booking terms and conditions, without exception, as set out herein.
2. We recommend telephoning to check availability for your chosen dates. Subsequent bookings must then be confirmed in writing. We will hold provisional bookings for 7 days by which time we must have received a 25% non-refundable deposit otherwise we retain the right to re-let the space. No booking can be considered confirmed until we have received a signed application and the deposit payment which will then be receipted by us. If we cannot accept the booking for any reason your deposit will be returned promptly but we cannot accept any liability for any delay or additional expense incurred as a result.
3. Payment of the balance of monies due must be made one calendar month prior to the start date of your stay, together with final confirmation of number of persons in your group. Cheques should be made payable to "Boulder Adventures Ltd." Alternatively, you can pay by debit/credit card (credit cards attract a 3% surcharge) over the phone, or by bank transfer.
4. You will be liable to us for any damaged caused, either directly or indirectly, by acts or omissions, to the accommodation or any fixture, fitting or furnishings therein. In addition to the final balance you must include an additional £50 damage/additional cleaning waiver deposit to cover the property and contents. This deposit will be returned in full within 2 days of your departure providing the premises have been left undamaged, clean and in the same state as those in which you found them on arrival. Reasonable deductions will be made in the event that we have rectification work to complete before our next guests can be accommodated. In the event of more major damage costing more than £50, you will be liable for the full cost of any repairs necessary as a result of your group's stay.
5. Our prices do not include any form of insurance. You are strongly recommended to arrange your own insurance to cover eventualities such as cancellation, injury or loss of personal items. We do not accept any responsibility for any guest's property of any description, including money, luggage, electronic equipment or vehicles and their contents.
6. In the event that you have to cancel your booking we will try to re-let the accommodation, without prejudice to our right to full payment should this not be possible.
7. We reserve the right to cancel any booking provided that, in such event, an attempt will be made to offer you an alternative accommodation or time. If no such alternative is available (such availability to be decided at the absolute discretion of us) you will be entitled to a full refund of all monies paid and all liability to us shall cease.
8. We do not accept any responsibility for any aspect of your accommodation affected by matters over which we have no control, for example weather conditions, industrial disputes, terrorism, delays, acts of God, war, quarantine, sickness or any other cause.
9. A member of our staff will be resident in the house during your stay and will be available to answer questions and to attend in the event of some emergency. However, the following items are given to make your stay more enjoyable whilst also protecting our property. You should ensure all members of your group are aware of these points.
10. The number of people staying must not exceed the number stated on the booking form. If it does we can refuse entry or make you leave before the end of your booked period. In either of these cases we will consider that your stay has been cancelled by you and that you will have no claim against us for compensation or reimbursement whatsoever.
11. You must treat the house and all the contents in a safe, sensible and reasonable manner so as not to cause damage to any of the decorations, fixtures, fittings, furnishings or equipment provided. You will be liable for any damage, whether wilful or not, and losses so caused. You will also show due consideration to other people, including our staff and neighbours, to prevent any nuisance or complaint. If any member of your party displays dangerous, offensive or rude behaviour we will ask you to leave the property immediately. In this case we will consider that your stay has been cancelled by you and that you will have no claim against us for compensation or reimbursement whatsoever.
12. Please ensure the accommodation is left in the same condition and state of cleanliness and order in which you found it on arrival. For your convenience and comfort a cleaner will attend each day between the hours of 09.30-11.30 approximately to clean all the communal areas only. Please allow easy access and note the cleaning of the kitchen is your responsibility.
13. The house is not to be used for loud or late parties, or any illegal purpose. No other persons apart from members of your group are to be allowed into the house or grounds, except by prior arrangement and agreement by us.
14. On the first day of your stay you may arrive between the hours of 16.00 & 23.00 and on your last day you must have vacated the property completely by 10.00.
15. We believe all bedding, cooking equipment, crockery, cutlery, etc., is provided for your normal use but, please note, we do not provide towels.
16. Children are welcome as part of your group but parents must be responsible for their children's behaviour and safety at their own risk. Please note we do not provide any cots, high chairs or other equipment or facilities specifically for use by small children or babies.
17. No pets are allowed in the house or grounds.
